I. Call for Applications

The Principal of the Budapesti Nemzetközi Iskola - International School of Budapest és Magyar - Angol Két Tanítási Nyelvű Általános Iskola és Gimnázium (hereinafter: ISB) announces a scholarship program for the 2026/27 and 2027/28 academic years.

The conditions of the Scholarship Program are defined as follows:

1. Objective of the Scholarship Program

The Scholarship Program aims to support Grade 8 students of ISB in the 2025/26 academic year who demonstrate outstanding academic performance as well as exceptional achievement in another field (e.g. sports, music, fine arts, etc.).

The purpose of the Scholarship Program is to ensure that highly talented students continue their secondary education at ISB, thus enhancing the institution's reputation and professional recognition.

2. Scope of the Scholarship Program

The scholarship is announced for Grade 8 students who hold an active student status with ISB in the 2025/26 academic year, supporting a maximum of **four students**.

Supported academic years: **2026/27**, and – subject to continued fulfilment of the conditions – **2027/28**.

Eligible students must meet at least the following commitments:

- Maintaining active student status at ISB at the time of application and throughout the 2026/27 and 2027/28 academic years;
- If awarded for exceptional performance in sports: participation in ISB sports teams and competitions designated by ISB;
- If awarded for exceptional artistic achievements: participation in art competitions announced for secondary school students;
- A minimum academic average of **4.5** (in every supported academic year, at mid-year and year-end);
- Maintaining outstanding academic achievement, obtaining commendable teacher recommendations, and participating actively and positively in community life.

Calculation of grade average:

Only core academic subjects are included (excluding physical education, music, visual arts, and technology/life skills). The academic average of mid-year and year-end grades must reach **4.5** or above.

The scholarship cannot be granted if the student's enrollment at ISB ceases during the school year. In exceptional, duly justified cases, the Principal may approve partial-year support at her discretion.

3. Eligible Applicants

Applications may be submitted by students who meet **all** of the following criteria:

- Active Grade 8 ISB student status in 2025/26 and intent to continue secondary studies at ISB;
- Excellent command of English;
- Academic average above **4.5** in every mid-year and year-end report during the last three completed school years (Grades 5, 6 and 7), and above 4.5 at mid-year in 2025/26;
- Outstanding achievement in sports or in music or another field of the arts.

4. Scholarship Award Process

ISB shall decide on the awarding of scholarships within **30 days** following the submission deadline.

If the successful applicant does not continue studies at ISB (does not gain admission or does not enroll in Grade 9), the decision shall **become void on May 1, 2025**.

ISB reviews compliance with the commitments no later than **15 days before the end** of the 2026/27 school year. If conditions are met, the student:

- is exempted from paying the tuition fee **to the extent granted by the scholarship**, and
- remains eligible for scholarship support in 2027/28.

The same review and decision procedure applies at the end of the 2027/28 school year.
Non-compliance results in **loss of scholarship eligibility**.

Where eligibility ceases (due to termination of student status or non-fulfilment of commitments), the legal guardian must repay, in a lump sum, within **8 calendar days**, the proportion of tuition that would have been covered by the scholarship.

The decision must be acknowledged by signature of the student's legal guardian, as it entails obligations for the student. As the student is not personally liable for repayment, no guardianship office approval is required.

ISB shall personally inform the legal guardian and provide a copy of the written decision.

Maximum scholarship amount:

Up to **50%** of the tuition fee for the respective academic level in **2026/27** and **2027/28**.

Factors ISB may additionally consider:

- dedication to English-language studies;
- contribution to school community activities;
- academic progress to date;
- social needs;
- results achieved in academic competitions.

5. Application Deadline

Applications must be submitted by **January 12, 2026**.

Applications are considered timely if submitted in person or posted **no later than midnight (24:00)** on the deadline date.

The submission date is the date of personal delivery or the postal stamp date.

6. Application Submission

6.1 Submission method

Applications must be submitted in hard copy, either in person or by post, to the following address:

6.2 Required content

Applications must include:

a) a completed and signed application form

(If joint parental custody applies, either parent may sign; otherwise, the parent holding exclusive

custody);

b) copies of documents evidencing compliance with eligibility requirements.

6.3 No correction possibility

There is **no opportunity** for supplementary documentation after submission.

6.4 Invalid applications

An application is invalid if the applicant:

- submits it in an incorrect format or incompletely;
- submits any part after the deadline;
- provides false or inaccurate information;
- does not grant consent to personal data processing as required by law.

7. Data Protection and Reporting of Changes

Throughout data processing:

- a) the highest reasonably expected security of personal data is ensured;
- b) appropriate technical and organisational measures protect against unauthorised or unlawful processing, accidental loss, destruction or damage;
- c) protection is ensured against unauthorised access, modification, transmission, public disclosure, deletion or destruction, accidental damage or unavailability due to technological change.

By submitting the application, the student (via legal guardian) undertakes to report **within 8 days** any change in personal data relevant to the evaluation of the application or scholarship eligibility.
